SAR Ladies Auxiliary Newly Formed in Indiana

The Indiana Society SAR and many local SAR chapters have been generous in including their ladies in SAR meetings and activities. An unofficial group of ladies sharing their interest in SAR evolved into the official formation of the Indiana Ladies Auxiliary Sons of the American Revolution during 2005.

The National Ladies Auxiliary of the Sons of the American Revolution was founded in California in 1984. Membership has since spread across the country and now into Indiana. The sole purpose of the ladies auxiliary is to support the SAR. Funds were raised by members of the national organization to purchase chairs for the Center for Advancing America's Heritage at a cost of \$500 each. That goal being met, the current project is now to purchase tables for the SAR Library. The national organization also sponsors meetings, luncheons and social events for ladies attending SAR National meetings as well as fund raisers.

At the State SAR meeting in Evansville, a check for \$200.00 was presented by Martha Barnhart of the Indiana Ladies Auxiliary to Indiana SAR State President T. Rex Legler II, to be used for the Indiana State youth program awards.

Ladies interested in membership need to be legally related to an SAR member in good standing. Proof of lineage to a Revolutionary War patriot is not required. Wives, mothers,

widows, sisters, daughters, nieces, aunts and adopted daughters qualify for membership.

Time flies when you are
having fun and I can tell
you now - it has been a

FUN year serving as your president! Many of the programs began several years ago have paid real dividends this year. In all honesty I can not take all the credit for them but , Boy am I glad they happened on my watch !!! Our membership continues to grow. We are approaching 700 if not already over that. We have a good number of Compatriots getting their first Liberty Medal for bringing in 10 new members as first line sponsors and we have a number of workhorses adding to their Oak Leaf Clusters. One Chapter - Daniel Guthrie - reports that EVERY member from 2005 has paid their dues in 2006 and they have added 10 new members bringing them over 75. I have already signed over 50 new member certificates for statewide distribution and there are yet more in the pipeline. The following chapters have added new members this year - Anthony Halberstadt, David Benton, Continental, Clarence Cook, Alexis Coquillard, George Rogers Clark, Daniel Guthrie, Alexander Hamilton, John Hay, William Knight, Thaddeus Kosciusko, Thomas Posey, and Ohio Valley. Additionally, several more Compatriots have become Life Members. Bob Burton has completed the exhaustive INSSAR History Revision and it is at the press now. We hope to have it mailed to all members registered in 2005 by our 29 April 2006 Annual Congress. Our INSSAR Color Guard with 2 more chapters joining in has had over 70 events where uniformed SAR Compatriots have marched, put on school programs, presented the colors, presented ROTC/JROTC awards, assisted in naturalization programs, put on programs for DAR chapters, Genealogical Groups, and County Historical Societies, and have been

great representatives for our society. More communities and civic organizations are asking for us to be present to add color and a bit of our nation's rich heritage to their proceedings. A special "hats off" to Compatriot Ed Hitchcock of Bloomington, who has single-handedly, gotten the SAR History teacher's CD into over 50 schools in south central Indiana. The Patriot Graves Registration Program continues to lead the nation with new Patriot burials being found in Morgan & Crawford counties. Our Youth Programs are going well with participation in the Knight Essay Contest, the Rumbaugh Orations contest, the CAR Scholarship, a huge expansion in the JROTC/ROTC effort, and our new 4-H Youth Initiative. What a great job was done by Roger & Martha Barnhart plus the Color Guard under the command of Steve Oberlin with 9 chapters represented at the Colonel LaBalme program which gained state & national recognition for the second Revolutionary War battle fought in Indiana. Of special emphasis were the honors rendered to the fallen on both sides of the conflict with the participation of the Miami Indian Tribe of Indiana. Involvement of Lieutenant Governor Becky Skillman at Vincennes along with Governor Mitch Daniels' Proclamation for the LaBalme ceremonies gives support and encouragement for our efforts at patriot education and commemoration. Out of state your INSSAR was represented at commemorative ceremonies at Fort Laurens, OH; Point Pleasant, WV; Bufford's Massacre, SC; Battle of Cowpens, SC, & King's Mountain, GA. There may be others yet before we gather again in Indianapolis on the 29th of April. Our great society is well represented in NSSAR Committees with Bob Howell on ROTC, Ted Williams chairing the Graves Registration committee, Rex Legler on Medals & Awards, Roger Barnhart on Resolutions, and Rex Legler on the Eagle Scout Committee chairing the national fundraising effort for Eagle Scout Scholarships. Your President has brought greetings to the Indiana Society, Children of the American Revolution; the Bloomington

Area Chapter, INSDAR; the Captain Henry Vanderburgh Chapter, INSDAR; the Hugh McGary Chapter, INSDAR; the Mary Bryan Chapter, INSDAR; the Washburn Chapter, INSDAR; and will bring greetings to the Indiana Daughters of the American Revolution on the 29th of April. I have also attended meetings at the Alexis Coquillard Chapter in South Bend, the Continental Chapter in Muncie, the Clarence Cook Chapter in Fishers, the David Benton Chapter in Brownstown, the Daniel Guthrie Chapter in Bedford, the John Hay Chapter in Salem, the Ohio Valley Chapter in Evansville, and the William Knight Chapter in Greencastle. I have represented you at the Central District meeting, Charleston WV; the Fall & Spring NSSAR Leadership meetings in Louisville KY, and the 2005 NSSAR Annual Congress in Louisville. Whew !!! What a whirlwind of activity. Who says there is nothing to do in the SAR? Guest Speaker at State Meeting:
James Alexander Thom, Author

Our featured guest speaker at the State Meeting in Indianapolis on April 29, 2006 is James Alexander Thom. A distinguished author, Thom was born and raised in the hills of Southern Indiana, and returned to live there after a long odyssey in less desirable places. He built a log cabin on a wooded ridge in Owen County where he resides with his Shawnee wife, Dark Rain, who is also an author.

A graduate of Arsenal Technical High School in Indianapolis, Thom enlisted in the U.S. Marine Corps during the Korean War, returned from Korea as a sergeant and completed his education at Butler University, Indianapolis. He was a reporter and columnist for The Indianapolis Star, and other newspapers, in the 1960s and 1970s, and worked on his novels while everyone else was sleeping. In many years as a free-lance writer, he lived on an old boat in Florida, several tents, while accumulating a world-class collection of rejection slips. He became such a connoisseur of rejection slips that he would sometimes send inferior ones back as unacceptable.

His freelance magazine credits include articles in the READERS DIGEST and NATIONAL GEOGRAPHIC and book criticism in The Washington Post. For 25 years he was editor and author of a highly unprofitable magazine of wit and essays called NUGGETS, which usually made enough money to keep him in

fresh typewriter ribbons. In the late 1970s he was a lecturer at the Indiana University School of Journalism. In 1995 he was awarded an honorary Doctorate of Humane Letters by Butler University. It hangs near his Best Novel award from the Western Writers of America and an eagle feather awarded by the Shawnee tribe.

In 1970 Thom's first deeply-researched historical novel, LONG KNIFE, was published, and since then he has been almost entirely immersed in the 18th and 19th Centuries. FOLLOW THE RIVER, which has sold a million copies, is used in both history and literature courses in high schools and colleges. PANTHER IN THE SKY, on the life of the famed Shawnee visionary and war chief Tecumseh, was the Western Writers of America's Best Novel choice in 1990 and was a Turner Network Television movie. FROM SEA TO SHINING SEA (1984) documented the saga of the Clark family of Virginia from the Revolutionary War to the Lewis and Clark Expedition. THE CHILDREN OF FIRST MAN (1994) and THE RED HEART (1997) show westward American expansion through the eyes of the Native Americans. Two subsequent novels, SIGN-TALKER: The Adventure of George Drouillard on the Lewis & Clark Expedition, and WARRIOR WOMAN: The Exceptional Life Story of Nonhelema, Shawnee Indian Woman Chief (this one co-authored with his wife), continue that viewpoint. Three nonhistorical books are the novel STAYING OUT OF HELL and two photographic books with lensman Darryl Jones, THE SPIRIT OF THE PLACE and INDIANA II. A novel on the Mexican War will be published in 2006. In his research Thom follows the routes and masters the tools and weapons of the people in his books. He is a woodcarver and an illustrator, and an avid conservationist.
