Report to the INSSAR House of Delegates

New Member Applications –

The NSSAR has updated and revised both its Applications Policy and Applications Handbook. Recently some applications have come through that do not meet the standards that NSSAR has put out. Please be sure to follow them. If you need a copy of the information please contact the INSSAR Secretary. Be sure to use the INSSAR Application Review Checklist and attach it to the application(s) before you send it to the registrar.

First Review of New Membership Approvals -

As part of the Recruitment and Retention of INSSAR Members, an initial review of New Member Approvals by year has been provided to the membership in Appendix A. For the last 6 years, with the exception of 2008, the INSSAR has hit a mark of over 40 new approved members each year, with 2011 as the peak in over 12 years with 55 new members approved. So far 2012 is on target to go well beyond the 55 mark as to date we have 49 approvals with another 9 new applications waiting for review.

Chapters -

- <u>Seth Jewel -</u> The Chapter (membership of 5) has asked to dissolve. The Executive Committee has
 worked with them through this process and has supported their decision based as only a couple
 of members are in Indiana with the balance out of state. The INSSAR Secretary has provided
 each member of the Chapter with pre-completed transfer form so all they need to do is fill in
 the new chapter they wish to be a member of.
- George Rogers Clark The Oldest Chapter in the state is in danger of folding. Compatriot
 Marshall Miller reports that he is no longer able to handle all the duties of all the officers and to
 date no one has volunteered to help with the leadership. If no leadership can be found, they
 have requested to merge into the Ohio Valley Chapter. INSSAR Secretary Eells has sent letters to
 all the Chapters dropped members (10) inviting them to rejoin the SAR family. INSSAR President
 Betzner would like to see the INSSAR come together with a plan of action to see that the
 Chapter remains viable.

NSSAR Database / Annual Reconciliation -

The INSSAR membership Reconciliation with NSSAR has been completed. During the process it was discovered that the INSSAR had been carrying Deceased and Dropped Members from as far back as before 2004. The INSSAR records and NSSAR records have been gone over with a fine tooth comb.

Membership Renewal/Drop -

Additional analysis is being conducted at the request of the INSSAR Executive Committee. I am in the process of completing the import process of all members who have dropped since 1999. I have already begun providing Chapters with this updated dropped list so they can review the information, research all the members so we can determine who has deceased and prepare for a major outreach to all those dropped members encouraging them to rejoin our SAR family.

Youth to Junior Conversions -

Just after the first of the year, I sent out 16 information packets to our Youth members explaining their status after the NSSAR dropped the program at Congress 2011. In that packet was the invitation to convert from YTH to JR for only \$5 at NSSAR + Any Chapter dues in 2012. To date 4 have taken advantage of the program. Please encourage any youth members your chapter may have to convert over as the INSSAR is not charging them dues for 2012 if they do.

INSSAR Handbook for New Members -

The new INSSAR Handbook has been created and is in its final editing phase. Once final edits are completed it should be published and made available to Chapters. INSSAR President Betzner has a proposal to fund this project.

INSSAR New Recruitment Tools -

Two new tools have been created for the INSSAR membership; an interest form and a general information sheet. Both of these tools are in final edits and once completed will be made available to Chapters. INSSAR President Betzner has a proposal to fund this project.

Hoosier Patriot -

Editor Jeff Hornung continues to do an amazing job with the Newsletter. We encourage all Chapters to submit information for publishing. One area of concern is that this is only emailed to members, and those members without email/computer access are not receiving communication from the State Society. This is great concern to the INSSAR Executive Committee, and is a contributing factor to increased membership drops.


INSSAR Chapter's reporting Update -

A new stone for Patriot Nicholas Jones was set in Jones or Yeley Cemetery in Bartholomew County. A stone has also been set for John Carney in Bick Cemetery, Bartholomew County– dedications are scheduled for 4 Aug 2012.

As you may know, the VA rejected the headstone order for James Anderson, buried in Sanborn Cemetery, Knox County, IN. Any descendant can request or put in writing for someone else to order a stone, or a cemetery official can order the stone. Ed Hitchcock is working on this procedure.

A headstone has been set for John Phillips – Greene County – Dedication TBA for 2012.

The stone at the grave of Patriot Jacob Kepler in Graves Cemetery in Perry County was set many years ago and is still in good condition. The cemetery has a lot of small briars and saplings that need to be cut. In addition, an access to the cemetery is need. The township trustee has been requested to help resolve this cemetery problem – no response has been received. Supervision of the problem still continues.

2010 - grave for Nathan Ricketts found on private property in Ohio County, IN - - old broken headstone has mostly been repaired and was erected – govt headstone to be ordered for 2012.

The VA rejection of the headstone order for John Carpenter has been resolved. The patriot is buried in Hicks Cem, Owen County – near Freedom, IN. Dedication ceremony is TBA

Edward Hitchcock is working on finishing the procedures for ordering headstones.

Mark Kreps is spearheading the efforts for developing classes pertaining to the "25 Most Prominent Patriots in Indiana". Presentations will be in Power Point slide. Suggestions are welcome.

Brad Manzenberger has been working on the restoration of 20 headstones in the Nay-Tremain cemetery in Johnson County, Indiana. Two of the headstones are for patriots – John McClintock and Samuel Nay. Restorations will be completed 4 July of this year. This project is going well.

Brad is interested in teaching proper restoration procedures to SAR members – details need to be discussed. The coordination of events for this project is between Brad and David Betzner.

There has been a proposal for a permanent SAR display in the War Memorial in Indianapolis. The display would feature Revolutionary Battles in Indiana. As per a conversation with the INSSAR President, the project is still "a go", but slow.

Researching cemeteries is an on-going situation - - Ed Hitchcock and Ron Burkhart spent a day in Decatur county cemeteries. Documentation materials were obtained from the local library. Two or three visits will be needed to get to some kind of finalization pertaining to patriot graves. We did find what turned out to be two patriots who are new – not in the INSSAR Patriot Grave web site – John Newton and Ichabod Parker. We did converse with the "local expert" on cemeteries in Decatur county -

- Russell Wilhoit is considered as the duty expert, majoring in cemetery restorations in general, with emphasis on veterans of all wars. Russell has been invited as a guest at our next INSSAR meeting.

At the present time, there is 2,241 names in my database.

From 2009 to 2012, we have a listing of 30 patriot names who did not appear in the INSSAR Patriot Graves web site. In 2009, Ron Burkhart created new web pages for 11 of those new patriots. 17 web pages need to be created for other new patriots. Two patriots on still in the investigative stage. A list of the new patriots is forthcoming.

The following compatriots have volunteered to devote time researching counties in Indiana: Brad Manzenberger – Johnson, Shelby, Henry, Marion and Jennings counties; Phil Greenwood – Marion county; Jim Arnold – Morgan county

Possibly research volunteers are David Jenkins – Warrick, Spencer, Perry and Vanderburgh counties as well as Allen Manning – Jefferson county.

From 2009 to 2012, as per my database, there has been 159 patriots whose cemetery locations, documentation, and photos have been completed.

It should also be noted since 2009, we have made it a part of the procedures to make record of the GPS reading for patriot graves and cemeteries.

It appears that the following counties are either completed or near completion: Switzerland, Ohio, Perry, Warrick, Spencer, Sullivan, Gibson, Rush, Decatur,

We are still interested in keeping track of grave dedication conducted in Indiana. Please contact Ron Burkhart.

NSSAR - Proposed medals for participants in Patriot Grave Markings – is still on hold pending better clarification of requirements.

In Jefferson County, the Maddox Cemetery was destroyed by the tornado and we are working with FEMA and the county cemetery commission to have it repaired. FEMA has been surveying the cemetery and provided a tree service the federal requirements to remove the trees, roots, and repair the grounds. FEMA will not repair the stones, but until the trees are removed, nothing can be done. Once FEMA completes the survey, the cemetery commission will need to talk to the county council for 25% of the funds. There's at least three Patriots buried there and this is where Compatriot Konkle wants to have a rededication ceremony someday. The one patriot, Jacob Fix, with a headstone had his stone rebroken during the tornado.

In Clark County, the Staples cemetery and in Scott County, the Barnes cemetery was damaged as well but I'm not sure if there are any patriots interred in either one.
